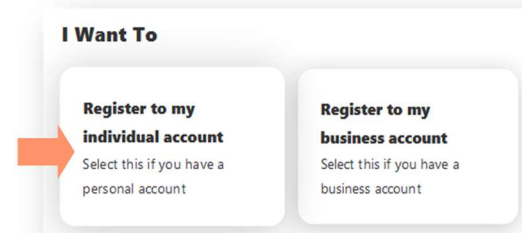
Step 1:

Visit our website <http://nutmegstatefcu.org> and select **Not Registered** toward the top of the page!



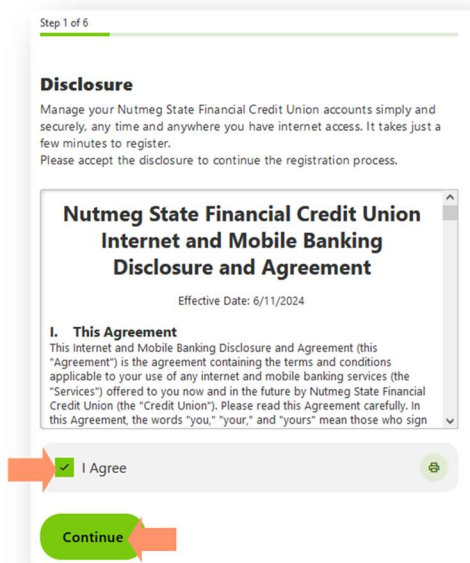
Step 2:

Select **Register to my individual account**



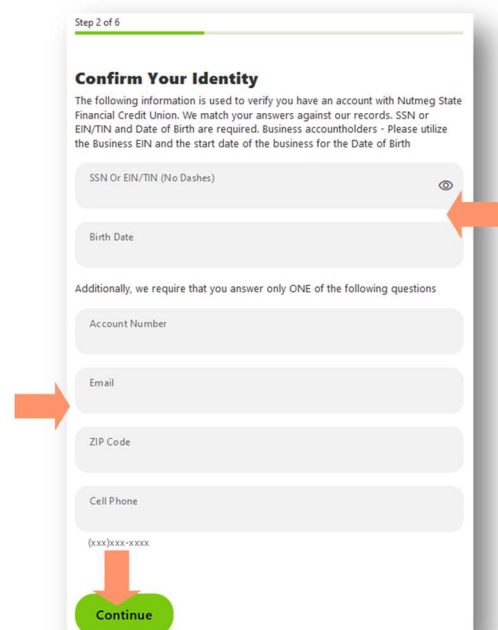
Step 3:

Step 4:

Verify your identity, by **entering your SSN or ITIN**, then **enter your date of birth** and **one of the questions below**. Then, click **continue**.



Step 5:

Choose a method of verification, then **continue**. *This security feature is to protect the account holder. **Your phone must be a cell phone for SMS text messages.**

SMS Text
A one-time code will be sent to your mobile phone.

Email
A one-time code will be sent to your email address.

Voice Call
You will get a call that reads a one-time code to you.

Step 6:

Enter your verification code and click **Verify**. For email verification, be sure to check your spam/junk folder.
